The Department of Congregational Development (DoCD) will reimburse churches within the Oklahoma Conference of The United Methodist Church up to one-half the cost of hiring professional fundraising consultants (up to a grant of \$20,000). Only consultants recommended by DoCD will be accepted. Funds may be used only for new construction or expansion of existing facilities. All applicants must submit the following form. Allow up to 4 months for reply.
