

# 2020 Clergy Appointments

**T**he Oklahoma Conference of the United Methodist Church has announced clergy appointments for 2020. Appointments are effective as of July 1.

In April, Bishop James Nunn announced several changes to district leadership, including the appointment of two new superintendents.

Rev. James Kim is the new superintendent for the Wichitas District. He has taken on the leadership role recently filled by Rev. Connie Gibson, who was moved to the Council Oak District upon the pending retirement of Rev. Cindy Havlik. Havlik will serve as assistant to the Council Oak district superintendent until her retirement on Aug. 1.

Rev. Carol Cook Moore is the new superintendent in the Northern Prairie District. She now fills the

role previously held by Rev. Tish Malloy, who has been appointed to lead the Crossroads District; Rev. Rockford Johnson had returned to the pastorate to lead Norman-McFarlin.

With the appointment of Kim and Cook Moore, five out of eight of the Oklahoma Conference's superintendents are either female or a person of color. Oklahoma has had female superintendents and people of color in the highest levels of leadership before, however, this is the first time a majority of the superintendents represent a minority race or gender.
